### **TRAVEL**

Australia - Transfer via Auckland or Wellington. Book early to secure a seat.  
Taupo is a small provincial airport about 15 mins from Tauhara by taxi or shuttle bus.

### **ACCOMMODATION**

The following accommodation options are available. Cottage 1 (Kowhai) – sleeps one single / one couple; Cottage 2 – single in a shared arrangement; Kereru Lodge – single in a shared arrangement; Bunk rooms – shared arrangements for couples and singles.  
All accommodation includes linen, blankets, pillow and towel **which we have booked for the Friday and Saturday nights only** and will allocate on a “first enrolled first-reserved” basis. If these are fully taken up (as they have in the past) or you prefer to have your own room, then please arrange alternative accommodation as follows:

Taupo Visitors Centre (Ph +64 7 376 0027) has motels listed (Taupo township is only a 10 minute drive from Tauhara). Westerman Real Estate (Ph +64 7 378 6163) also rent several private houses. The Great Lake Holiday Park (Ph 07 378 5159) has cabins 3km away on Acacia Bay Road. Note that you’ll need to arrange your own daily transport if staying off-site.
