**BEING LISTED ON OUR  
2007 IDT REGISTER of COUNSELLORS, SUPERVISORS, and REGIONAL COORDINATORS**

Dear IDT Advanced Course graduate

We are currently updating our IDT REGISTER and are writing to you to see if you would like to be included in this publicly issued document. You can view its 2006 layout by going to our website. Our updated criteria for inclusion are contained in the following description (which will also be printed on our Register):

**IDT REGISTER**

We regularly get asked for the names of IDT Counsellors and IDT Supervisors. In addition new IDT graduates ask for the contact details of local IDT Co-ordinators so they can join the local IDT peer support group. This Register lists the IDT people we currently know of in each region, and exists solely to support the learning and use of IDT. We will be pleased to add further names as they come to hand.

Listing in this Register as an **IDT COUNSELLOR** is not an endorsement of professional skill, suitability or competency, but simply an acknowledgement that the counsellor has: - completed the IDT Advanced Course, claims to consistently use IDT as one of their main modalities, has full membership in the New Zealand Association of Counsellors (or recognised equivalent), has been in professional practice for at least two years, receives IDT supervision, and keeps up-to-date with IDT developments.

Listing as an **IDT SUPERVISOR** means that in addition to the above IDT counsellor pre-requisites, the supervisor has completed an approved supervision training course (from an outside agency), has at least one year's active experience as a supervisor, and receives regular supervision themselves.

The **IDT REGIONAL COORDINATOR** arranges meetings (at least quarterly) of local IDT'ers who have done the IDT Foundation Course, to meet as a peer support group for IDT discussion, practice and self-work. The pre-requisite for this position is simply completion of the IDT Foundation Course, and enthusiasm for IDT
